

EASTFIELD RESOURCES FACT SHEET



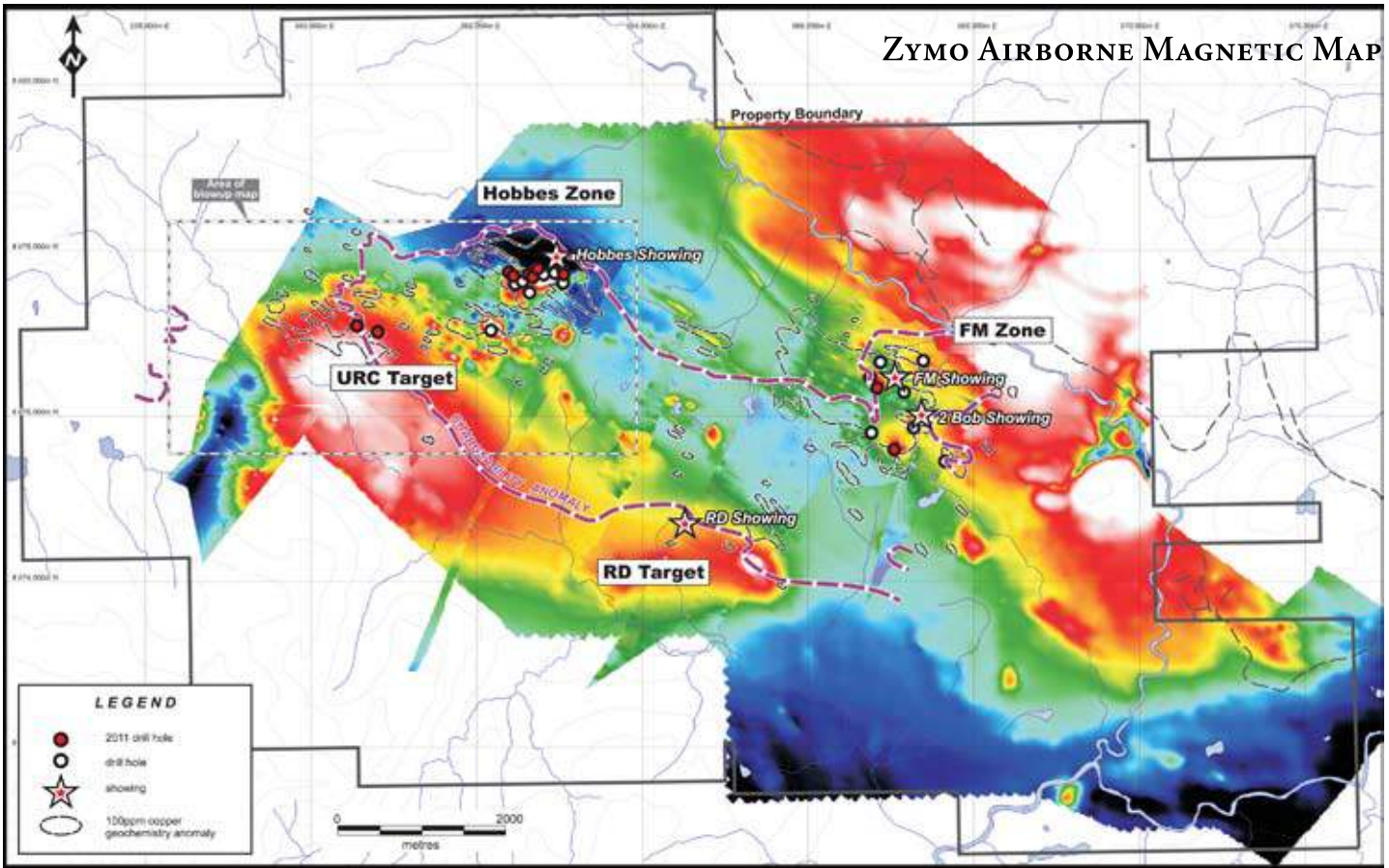

Eastfield offers a balanced portfolio of metals and projects for investors in one public company. Since its inception in 1987 Eastfield has operated with a business strategy of funding exploration by optioning its properties to other companies. This strategy reduces risk, increases leverage and minimizes share dilution.

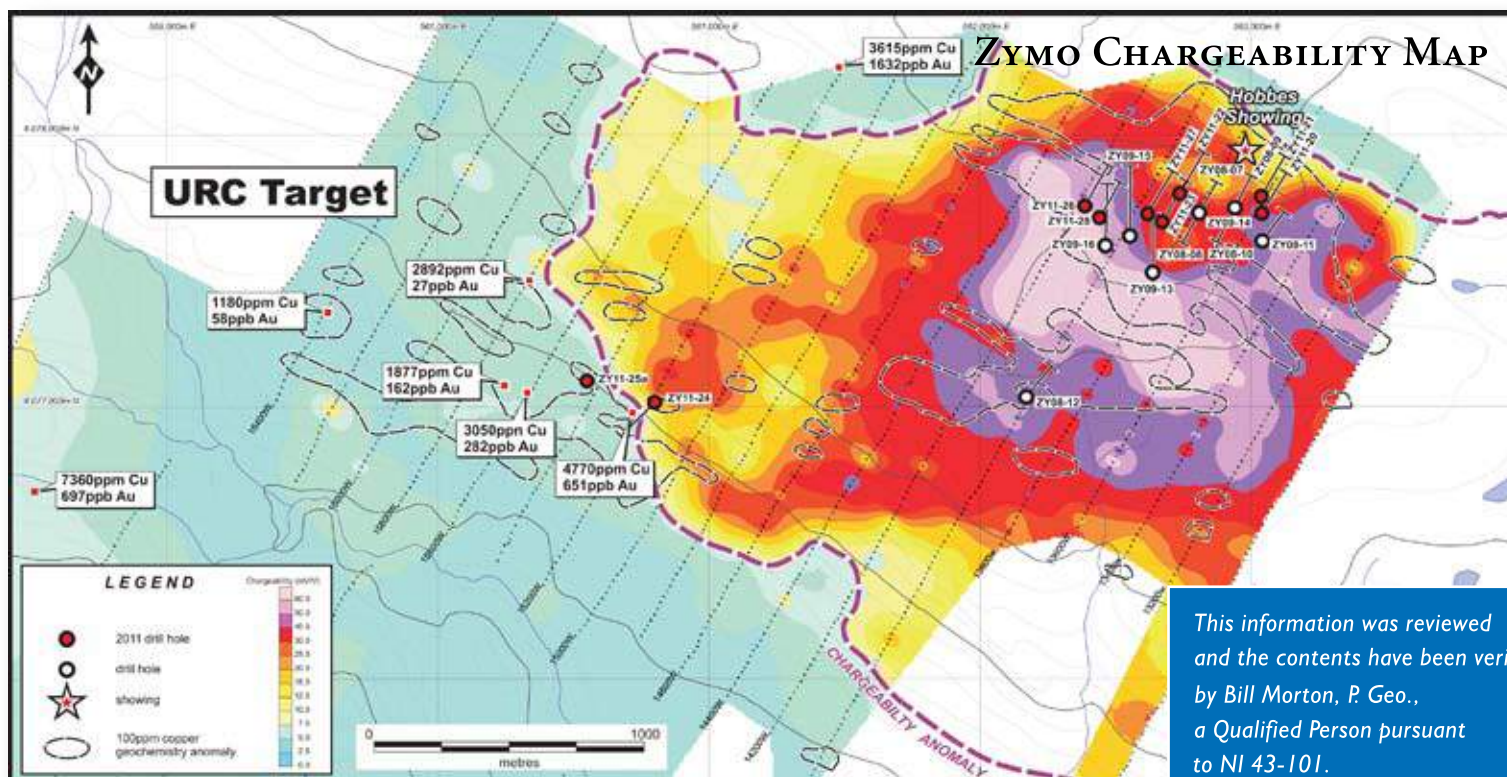
Cariboo Rose Resources (TSX-V: CRB) and Lorraine Copper (TSX-V: LLC) all have their origins in Eastfield, demonstrating the success of the business model.

CURRENT PROJECTS

ZYMO - COPPER AND GOLD

- The 12,113 hectare Zymo property is located 45 kilometres west of the town of Smithers, in northwestern BC.
- Several porphyry copper-gold targets occur in and around an 8 km x 2 km IP chargeability anomaly.
- Recent drilling of the newly discovered Hobbes Zone intersected 72.0 metres grading 0.72% copper and 0.54 g/t gold starting at 15.0 metres depth.

CURRENT PROJECTS (CONT.)

OK - COPPER AND MOLYBDENUM

- The 5,233 hectare OK porphyry project is located in southwestern BC, near the coastal city of Powell River.
- An NI 43-101 compliant inferred mineral resource at the North Lake Zone has been calculated to be 86.8 million tonnes that grades 0.31% copper and 0.014% MoS₂ at 0.20% copper cut off.
- North Lake is only one of eight zones of mineralization known to exist on the OK property.
- OK is a joint venture with Prophecy Coal Corp. (60%) and Eastfield (40%).

INDATA - COPPER AND GOLD

- The 3,041 hectare Indata property is located northwest of Prince George, BC.
- Several styles of mineralization exist on the Indata property, including gold-silver veins and porphyry-style copper and gold. Drilling in 1988 intersected 4 metres grading 47.3 g/t gold.

TONOPAH-HUGHES - GOLD AND SILVER

- The Tonopah Mining District was one of the preeminent gold and silver producers in the US.
- Eastfield has a 100% interest in 18 patented claims and has sold seven claims to West Kirkland Mining Ltd. under a staged purchase agreement.

IRON LAKE - COPPER, GOLD, SILVER AND PGM

- The 7,300 hectare Iron Lake property is located in south-central BC.
- In 2005 four drill holes were completed at Iron Lake. One of the holes intersected 6 metres of massive sulphide mineralization, with the higher-grade portion of the hole having 0.95% copper, 0.10% nickel and 0.08% cobalt.

NAGGIE - COPPER AND GOLD

- Located 50 km southwest of the City of Williams Lake.
- Attention to the prospect was drawn from a prominent orange to yellow gossan that is exposed in a road with a resemblance to the Maggie porphyry gossan.

BIG VALLEY - COPPER AND GOLD

- The Big Valley project is located 15 kilometres north of Barkerville in central BC.
- Big Valley consists of three road-accessible claims, named Hedge Hog, Antler and CR which are highly prospective and have active placer gold mines on and around the them.
- The historical gold production in the Barkerville and Wells area (~4 million ounce placer production and ~1.2 million ounce hard rock production), in addition to the occurrence of numerous boulders of massive sulphide mineralization, are the focus of exploration.
